## **DECLARATION OF THE GENERAL MANAGER REGARDING ENVIRONMENTAL POLICY OF S.C. ELECTROCENTRALE DEVA S.A.**

S.C. Electrocentrale DEVA S.A. is a company that focuses on continuously increasing customer satisfaction whilst mitigating the impact of the company's activities on the environment.

Within the organization of S.C. Electrocentrale Deva S.A., the environmental management policy is based on the sustainable development principle: *"The right to development must be fulfilled so as to equitably meet developmental and environmental needs of present and future generations."*

In order to apply this principle, the management of the company has decided and undertakes to implement, maintain and continuously improve an Integrated Quality and Environment Management System in compliance with the requirements of standard SR EN ISO 14001:2005 – „Environmental Management System. Specification Guidance for Use” and SR EN ISO 9001:2001.

The environmental management policy is documented, implemented and maintained, and it is appropriate for the nature, extent and environmental impact of the company's activities, products and services.

The company management undertakes to:

- observe and continuously comply with legal requirements and other relevant regulations regarding environmental issues;

6. *Implementation of the necessary investment projects to mitigate the impact on the environment by modernization and rehabilitation of the existing plant and equipment.*
